Cllr Hockin proposed the council support this application. Seconded by Cllr Munden. 3 in favour. Cllr Simmonds abstained.

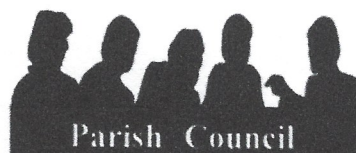
