Cllr Edwards-Symons re-joined the meeting.

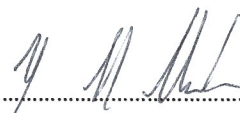
05.05 **Minutes**

- Cllr Simmonds proposed the minutes of the 8th April be signed as a true and correct record, this was seconded by Cllr Bright and agreed with 6 for and 4 abstentions

- Cllr Edwards-Symons proposed the minutes of the 22nd April be signed as a true and correct record, this was seconded by Cllr Edwards and agreed with 6 for and 4 abstentions
- Cllr Simmonds made reference to 3.05 on the minutes of the 20th May, it had been transferred from the previous minutes and suggested it be deleted and this was seconded by Cllr Edwards-Symons and agreed. Cllr Simmonds proposed the minutes of the 20th May be signed as a true and correct record, subject to the amendment, this was seconded by Cllr Yates and unanimously agreed

05.06 Items from previous meeting

1. **Covid-19** B Jordan reported that as of this morning there were no serious cases in hospital
Other reports were that testing is possible for everyone and Track & Trace is in place in all public buildings
2. **Website** A report was circulated, and discussion took place about the work that had been done, develop a new website, rebranding etc.
Thanks' were expressed to John Waklin for the work he had done on the existing website, investigations into website developers and the new site will be the 'Forrabury and Minster PC' with links to other groups in the community. Cllr Yates proposed that they get 2 proposals and report back at the next meeting
3. **Highways** Cllr Bright reported on the problems at Pennally Hill that if two buses meet, there is a problem passing because of the overgrown hedge.
Oliver Jones will be notified by the Cornwall Councillor
The triangle is overgrown at Toptown and the grass needs cutting but because of parked cars it is difficult. Cllr Yates proposed the 3 fence posts and signs be put up giving 24 hours notice that the grass would be cut, this was seconded by Cllr Edwards and agreed
Cornwall Councillor will check the consultation period for the TRO in Boscastle
4. **W.I.** The scarecrow challenge was a success, funding for the defibrillator is in place awaiting confirmation from doctors surgery re installation. The telephone box in the harbour was ongoing and there is a charity event on Sunday
5. **Works around the village.** Notice Boards, Clerk to check and report back, Ash Dieback Cornwall Councillor will contact Cornwall Council Tree warden
The panoramic walk is deteriorating and need repair, Clerk to contact Jeff Charrington National Trust
Cllr Potter will check overhanging pipe
6. **NDP.** Following on from the meeting on Tuesday the grant had been approved and have until March 2022 to use it, output from groups is needed
Cllr Bridges stated that there is a need to tie up loose ends
F & MPC agreed to continue support and help to form new group and help get community support and updates in the blowhole. Cllr Yates read a

- statement and proposed that it be published in the Blowhole, this was seconded by Cllr Edwards and agreed with 9 in favour and 1 abstention
7. **Graveyard.** Cllr Ferrett suggested that a working group/sub-committee be set up to look into acquiring more land for burials, this was proposed by Cllr Bright, seconded by Cllr Yates and agreed with 9 in favour and 1 abstention
 8. **Playground.** Cllr Ferrett reported on the ROSPA report, some equipment will need replacing and this will need to be phased. The perimeter fence is in a bad way and needs some work, the swings need attention and waiting for quotes and what different options which are available
 9. **Dog Warden.** Cllr Potter has someone who is interested and will pass the details to the clerk.
 10. **Camelford Community Network.** The next meeting is on the 29th June
 11. **CIC/BCTC.** New website has been set up for the CIC
 12. **Castle Site.** Some dog walkers are allowing their dogs to run free and leaving dog mess, Cllr Bright proposed that warning notices be put up to include 'all dogs must be kept on a lead' this was seconded by Cllr Potter and unanimously agreed. The bench needs some work to bring it back into use, clerk to prioritise a walk around by councillors
 13. **Car Park.** The CIC are in talks with CC regarding the area used for recycling Cornwall Councillor will try and organise a meeting with Tina McGrath and Ken Polmounter at the car park.
 14. **Bus Shelter.** Looks great and comments have been received complimenting the PC
 15. **Bottreaux Rise Wall.** Ongoing
 16. **Banking.** Carry Forward to the next meeting when the clerk will be back
